**WORKSHOP ON NEW LABOUR CODES AND COMPLIANCES AT AYODHYA,
UTTAR PRADESH**

In a landmark reform, the Government of India has announced the implementation of the four consolidated Labour Codes — **The Code on Wages, 2019; The Industrial Relations Code, 2020; The Code on Social Security, 2020; and The Occupational Safety, Health and Working Conditions Code, 2020** — with effect from **21st November 2025**, replacing and rationalizing 29 existing labour laws. These reforms are aimed at modernizing labour governance, enhancing worker welfare, improving ease of doing business, and aligning India's labour framework with contemporary global practices. This transformative step lays the groundwork for a future-ready workforce and more agile, resilient industries, strengthening the labour ecosystem in line with the vision of **Aatmanirbhar Bharat**. After participating in the workshop the trainee officers shall have updated their knowledge and skills in the following areas:

- Statutory Compliances and Returns for organizations
- Understanding the key changes, major objectives and features of the various labour Codes-
 - Code on Wages, 2019
 - Code on Social Security, 2020
 - Industrial Relations Code, 2020
 - Occupational Safety, Health and Working Conditions Code, 2020
- Understand the Roles and responsibilities of various bodies and authorities in administering the provisions of the Labour Codes
- Understand the implication of these codes on the labour market-how the reforms will address the issues of the workers and impact the employers and their businesses.

Workshop Methodology

The workshop will be organized on highly participative lines. The training methods will include lectures, group discussions, exercises, presentations, case studies, etc.

Faculty

Sh. Rajan Verma is former advisor to Ministry of Labour & Employment, Government of India. He has recently retired from the post of Chief Labour Commissioner (Central), Government of India. He is M.Com, LLB, Post Graduate in Labour Laws with Post Graduate in Industrial Relations & Personnel Management. He have attended 2 International training programs on Labour Inspections and Labour Administration & OSH in International Training Centre for International Labour Organization (ILO) at Turin, Italy. He has also participated as delegate from India in meetings, workshops of ILO on various subjects like Forced Labour at Rio de Janario, Brazil; Review of Conventions & Recommendations at ILO Geneva, Switzerland and Disputes Resolution Mechanism workshop by ILO at Dhaka, Bangladesh.

Dr. Onkar Sharma is a distinguished labour policy expert and former Chief Labour Commissioner, Government of India, with over four decades of leadership in labour administration, legislative reforms, industrial relations, and welfare policy. With his strong academic foundation in commerce, law, and labour studies, he has combined scholarly insight with practical experience to advise governments on aligning labour laws with contemporary socio-economic realities, simplifying compliance frameworks, and promoting facilitative governance models. He has been instrumental in framing the National Labour Policy, drafting India's Labour Codes, amending key labour legislations, and contributing to international reforms as a member of the ILO Standards Review Mechanism, Geneva. Dr. Sharma has also developed labour policies and built institutional capacity for Afghanistan under a UNDP programme. A passionate advocate of workers' rights and sustainable industrial growth, he has held pivotal positions including Dy. Director General (Labour Welfare), Government of India, and CEO & Welfare Commissioner, Delhi Labour Welfare Board. Renowned for his capacity-building initiatives, he has trained labour administrators, judicial officers, employers, trade union leaders, and academics, and has been a guest faculty for leading national and international institutions such as ILO, UNICEF, UNDP, World Bank, NHRC, and premier civil services academies. Widely published and frequently invited to global platforms, Dr. Sharma continues to play a vital role in shaping labour governance, advancing welfare schemes, and strengthening social security, particularly for vulnerable groups such as unorganised, construction, digital platform, and gig workers.
