## **WORKSHOP ON PROJECT FINANCING AT GANGTOK, SIKKIM**

In the wake of rapid infrastructure expansion, Government organizations and Public Sector Undertakings (PSUs) are transitioning from traditional budget-funded models to more complex, revenue-generating frameworks. The success of contemporary infrastructure projects across sectors such as Energy, Transport, Urban Development, and Defence now depends not only on engineering excellence but equally on robust project financing structures. Increasing pressure to reduce reliance on sovereign or state guarantees, the push for asset monetization under initiatives such as the National Monetisation Pipeline, capital constraints on public budgets, and the growing use of Public-Private Partnership (PPP) models have significantly altered the project development landscape. In this context, the ability to structure, evaluate, and manage large-scale capital projects using non-recourse or limited-recourse financing, effective risk allocation, and sound financial appraisal has become a critical capability for public sector officials. This workshop is therefore designed to equip participants with practical insights and tools to ensure bankable, sustainable, and financially viable infrastructure projects. After participating in the workshop the participants shall have updated their knowledge and skills in the following areas:

- Enhances financial discipline and risk mitigation.
- Improves cost efficiency through optimal capital structuring.
- Supports development of bankable contractual frameworks.
- Strengthens competence in project financial structuring.
- Improves understanding of core financial appraisal tools.
- Practical understanding of key lender metrics such as DSCR, IRR, and NPV
- Enables critical evaluation of DPRs and financial assumptions.

### **Workshop Methodology**

The workshop will be organized on highly participative lines. The training methods will include lectures, group discussions, exercises, presentations, case studies, etc.

## **Faculty**

Subject experts having practical knowledge and understanding of the subject will be invited as faculty for the present subject.
